The Class Representative and each Settlement Class member who have not properly excluded themselves shall take nothing from their complaint in this action except as set forth in (i) the Final Approval Order; (ii) Settlement Agreement; and (iii) the Order Granting Motion for Approval of Attorney's Fees, also filed February 8, 2023.
